- Rebate application with valid customer account number must be accompanied by a **legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, model number, store/name, store location, purchase price, and date of purchase.**
- Please allow up to 30 days from the date all required information is received to process your rebate. **For the fastest rebate possible, submit your rebate application online at energysavePA.com/rebates.**
- All rebated products must be used at the service (install) address specified on the rebate application.
