FirstEnergy's Pennsylvania Utilities Rebate Requirements

- Applicant must be a Pennsylvania residential customer of Met-Ed, Penelec, Penn Power or West Penn Power, FirstEnergy's Pennsylvania utilities.
- Rebate applications are valid for qualified appliances purchased between June 1, 2021, and May 31, 2026.
- Rebate application must be submitted within 90 days of purchase and be postmarked by June 6, 2026.
- Rebate application with valid customer account number must be accompanied by a legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, model number, store name and location, purchase price, and date of purchase.
- Payment will be issued to the account holder and mailing address on record with the utility.

- Please allow up to 30 days from the date all required information is received to process your rebate. For the fastest rebate possible, please submit your rebate application online at energysavePA.com/rebates.
- All rebated products must be used at the service (install) address specified on the rebate application.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
- FirstEnergy's Pennsylvania utilities and/or their designees including program administrators do not endorse any manufacturer or product as part of this program.
- For refrigerators and/or electric clothes dryer, models that qualify for the \$25 rebate must be listed as ENERGY STAR. Models that qualify for the \$50 rebate must be listed as ENERGY STAR Most Efficient.
